UMCU Visa® Giveaway Official Rules

1. **How to Enter:** UMCU's Giveaway begins on August 12, 2025 at 9:00 a.m. EST and ends August 26, 2025 at 9:00 p.m. EST. All entries must be received by August 26, 2025 at 9:00 p.m. EST. Entries are required to be received by the following method:

- a. **Automatic Entries: Members** – An applicant will automatically receive one (1) Giveaway entry for every 10 utilizations of the member's UMCU Visa® card during the promotional period. Registration is required to qualify for the giveaway. This offer is valid for University of Michigan Credit Union Visa® credit card holders only. In the event of a dispute as to who submitted a particular entry, such entry will be deemed to be submitted by the primary person in whose name was used to enter the Giveaway. Automatic entries must be made by 9:00 p.m. EST on 8/26/2025, in order to be eligible.
- b. **To enter without purchase or obligation by U.S. Postal Entries:** Submit one (1) entry during the drawing time frame. To be eligible, send a note card complete with individual's name, address, city, state, zip, telephone number and valid email address to the following address. Must be postmarked (by USPS) by 8/26/2025 and no later than 9:00 p.m. EST on 8/26/2025 to be entered into the UMCU Visa® Giveaway Mail to: University of Michigan Credit Union, Attn: Marketing Department/Drawing, P.O. Box 7850, Ann Arbor, MI 48107-7850.

2. **Prize Eligibility:** Officers, directors and team members of UMCU are not eligible. Also not eligible are immediate family members (spouse, parent, child, and sibling) of the aforementioned, nor any persons residing in the same household. Participation in the sweepstakes and eligibility to win prizes is limited to legal residents of the State of Michigan.
