

**UNIVERSITY OF MICHIGAN CREDIT UNION
STUDENT MAILER GIVEAWAY
OFFICIAL RULES**

- a) **How to Enter:** The UMCU Student Mailer Giveaway begins on June 1, 2019 and ends September 30, 2019. All entries must be received by September 30, 2019, 11:59p.m. EST. Entries are required to be received by the following method:
- a. Automatic Entries: University of Michigan students who open a new account will automatically be entered to win. Automatic entries must be made by 11:59pm EST on 9/30/19 in order to be eligible.
 - b. To enter without purchase or obligation by U.S. Postal Entries: Submit one (1) entry during the drawing timeframe. To be eligible, send a note card complete with individual's name, address, city, state, zip, telephone number and valid email address to the following address. Must be postmarked (by USPS) by 6/1/2019 and no later than 11:59 p.m. EST on 9/30/19 to be entered into The UMCU Student Mailer Giveaway. Mail to: University of Michigan Credit Union, Attn: Marketing Department/Drawing, P.O. Box 7850, Ann Arbor, MI 48107-7850.
2. **Prize Eligibility:** Officers, directors and team members of UMCU are not eligible. Also, not eligible are immediate family members (spouse, parent, child, and sibling) of the aforementioned, nor any persons residing in the same household. Participation in the sweepstakes and eligibility to win Prizes is limited to legal residents of the State of Michigan. All participants must be at least eighteen (18) years of age and a legal resident of the State of Michigan.
3. **Grand Prize:** One (1) winner will receive tuition valued at \$5,000. Claiming period for the Prize is 7 days after the winner is contacted directly and informed of his or her prize.
- a) **First Prize:** One (1) winner will receive one (1) Bose Solo 5 TV Sound Bar, one (1) Apple Watch Series 4*, one (1) pair of Apple AirPods with Wireless Charging Case*, (1) Toshiba 50" Smart 4K TV – Fire TV Edition, one (1) Sony PlayStation 4 Pro Console, one (1) Amazon Echo Plus 2nd Generation with Philips Hue Bulb. *If winner does not have Apple products, he/she can exchange for similar product of different brand of equal or lesser value. Claiming period for the Prize is 7 days after the winner is contacted directly and informed of his or her prize.
 - b) **Second Prize:** One (1) winner will receive two (2) tickets to the Michigan vs. Notre Dame Football Game on October 26, 2019, passes to watch the pregame warm-up on the field, dinner before the game in Ann Arbor (Pretzel Bell), and an autographed Jim Harbaugh football. Claiming period for the Prize is seven (7) days after the winner is contacted directly and informed of his or her prize.

A Credit Union representative will randomly draw one (1) winner at the drawing. Winner needs not be present to win and will be notified by phone, email, if available, and/or mail. The winner will be required to sign an affidavit of eligibility (which affirms that he/she has complied with these rules) which must be completed, signed and returned within seven calendar (7) days from date of issuance, or the Prize will be forfeited and awarded to an alternate winner. If any Prize notification or attempted notification is returned undeliverable, the Prize will be forfeited and awarded to an alternate winner. If a winner cannot be contacted within five (5) business days of the drawing date, the Prize will also be forfeited and an alternate winner will be selected.

Total Approximate Retail Value ("ARV") of Grand Prize: \$5,000.00. Total Approximate Retail Value ("ARV") of First Prize: \$1,630. Total Approximate Retail Value ("ARV") of Second Prize: \$2,500. Entrants also agree to hold UMCU and each of its officers, directors, team members, members and representatives, and agents harmless from any liability arising from participation, or the acceptance of a Prize.
