UMCU TOUCHDOWN TAILGATE
OFFICIAL RULES

1. **How to Enter:** UMCU Touchdown Tailgate begins on September 22, 2023 at 2:00 pm EST and ends September 22, 2023 at 6:00 p.m. EST. All entries must be received by September 22, 2023 at 11:59 p.m. EST. Entries are required to be received by the following method:
 - a. **Automatic Entries: Members** – An applicant will automatically receive one (1) Raffle entry for entering a valid email address during the promotional period. In the event of a dispute as to who submitted a particular entry, such entry will be deemed to be submitted by the primary person in whose name was used to enter the Raffle. Automatic entries must be made by 11:59 p.m. EST on 9/22/23, in order to be eligible.
 - b. **To enter without purchase or obligation by U.S. Postal Entries:** Submit one (1) entry during the drawing timeframe. To be eligible, send a note card complete with individual's name, address, city, state, zip, telephone number and valid email address to the following address. Must be postmarked (by USPS) by 9/22/23 and no later than 11:59 p.m. EST on 9/22/2023 to be entered into the Touchdown Tailgate Raffle Promotion. 2. **Prize Eligibility:** Officers, directors and team members of UMCU are not eligible. Also not eligible are immediate family members (spouse, parent, child, and sibling) of the aforementioned, nor any persons residing in the same household. Participation in the sweepstakes and eligibility to win Prizes is limited to legal residents of the State of Michigan. All participants must be at least eighteen (18) years of age and a legal resident of the State of Michigan. Prospect-aged individuals (excluding 6th through 12th grade aged children) are not eligible for the Michigan Football Experience Prize.

If any Prize notification or attempted notification is returned undeliverable, the Prize will be forfeited and awarded to an alternate winner. If a winner cannot be contacted within five (5) business days of the drawing date, the Prize will also be forfeited and an alternate winner will be selected.

The winner will be required to sign an affidavit of eligibility (which affirms that he/she has complied with these rules) which must be completed, signed and returned within seven calendar (7) days from date of issuance, or the Prize will be forfeited and awarded to an alternate winner. If any Prize notification or attempted notification is returned undeliverable, the Prize will be forfeited and awarded to an alternate winner. If a winner cannot be contacted within five (5) business days of the drawing date, the Prize will also be forfeited and an alternate winner will be selected.
